

# **7th INTERNATIONAL YOUNG PIANISTS COMPETITION "POLIFONIJA IR AŠ" (POLYPHONIA AND ME )**

## **PROVISIONS**

### **I. GENERAL PROVISIONS**

The regulations of the international competition of young performers "Polyphony and Me" regulate the purpose and tasks of the competition, organizers, partners, conditions of the competition, organizing commission, place and time, awards, funding.

### **II. OBJECTIVES AND TASKS OF THE COMPETITION**

- To stimulate students' interest in polyphonic music;
- To reveal the individuality of young musicians, the mastery of the performer, to enrich their concert practices using new innovative working methods.
- To encourage students' self-development, creativity, desire to express their knowledge through music;
- Encourage cooperation between music schools, give teachers the opportunity to share professional experience.

### **IV. ORGANIZING COMMITTEE OF THE COMPETITION**

- Competition director Aurelija Stončiuvienė, Radviliškis Music School headmaster, piano teacher methodologist;

- Competition coordinator Dovilė Čiužienė, teacher of Radviliškis Music School.

### **V. CONDITIONS OF THE CONTEST**

- Young pianists from music and art schools can participate in the competition.
- Students are divided into four age categories:  
Category **A** Pupils studying in classes of music school 1-2.  
Category **B** Pupils studying in 3-4 music school classes.  
Category **C** Pupils in 5-6 music school classes.  
Category **D** 7-8 and students studying in the classes of a music school of purposeful education.
- Contestants perform two pieces: a polyphonic piece; freely chosen play
- Pieces are performed by heart. Repetitions in the work are optional.
- After submitting the tender application, the repertoire cannot be changed.

### **VI. TIME AND PLACE OF THE CONTEST**

- The competition will be held in **2024 on May 29** at the Radviliškis Music School (Žalgirio st. 10, Radviliškis)
- The order of performance of the participants is determined by the organizers.

## X. PROCESSING OF PERSONAL DATA OF EVENT PARTICIPANTS

### OBJECTIVES AND BASIS

- Radviliškis Music School (hereinafter - the School), legal entity code 290713820, address Žalgirio st. 10, LT-82179 Radviliškis, is the controller of the personal data of the event participants, responsible for collecting and processing the personal data of the event participants.
- Participants or their representatives provide personal data voluntarily when registering and coming to the competition organized by the School. The following data are processed for the purposes of organizing the competition, its implementation and the participant's participation in it:

- information about the participant's name, surname, age, educational institution, name and surname of the teacher accompanying the participant are processed for the purpose of organizing the competition;

- information about name, surname, age is processed for the purpose of organizing awards;

- image, footage - for the purpose of publicizing the School's activities on the Facebook account, the School's website, and in the media.

- Each contestant or his representative, by registering and coming to the contest, agrees that the School will handle 2.1 - 2.3. listed personal data on the basis of consent in accordance with Article 6 of the General Data Protection Regulation. 1 d. (a) p.

- The data of the participant and the accompanying person are stored for one year after the organization of the competition. Photos and videos are stored for 3 years after the day of the competition.

- The participant or the person representing him/her has the right to request that the School allow access to the participant's personal data and correct or delete them, or to limit data processing, as well as to object to personal data being processed for the purpose of direct marketing.

- The participant has the right to contact the School's data protection officer by e-mail regarding personal data protection issues. by e-mail [info@saugostinklas.lt](mailto:info@saugostinklas.lt) or file a complaint with the State Data Protection Inspectorate regarding the School's actions (inaction), which, in the participant's opinion, violate the provisions of legal acts.

- The representatives (teachers) of the minor participants in the competition are responsible for informing the representatives of the minor participants (parents/guardians) according to the law about the personal data processed by the School during the competition, and thus receiving consent confirming the right of the minor participants to participate in the competition/festival organized by the School.
