

# **5th INTERNATIONAL VIRTUAL YOUNG PIANISTS COMPETITION "POLIFONIJA IR AŠ" (POLYPHONIA AND I )**

## **PROVISIONS**

### **I.GENERAL PROVISIONS**

The regulations of the international competition of young performers “Polyphony and I” regulate the purpose and tasks of the competition, organizers, partners, conditions of the competition, organizing commission, place and time, awards, funding.

### **II.OBJECTIVES AND TASKS OF THE COMPETITION**

- To stimulate students' interest in polyphonic music;
- To reveal the individuality of young musicians, the mastery of the performer, to enrich their concert

practices using new innovative working methods.

- To encourage students' self-development, creativity, desire to express their knowledge through music;
- To awaken the student-performer's ability to emotionally influence the listener by means of information technology;
- Encourage cooperation between music schools, give teachers the opportunity to share professional experience.

### **III. COMPETITION ORGANIZERS**

### **IV.ORGANIZING COMMITTEE OF THE COMPETITION**

- Competition director Aurelija Stončiuvienė, Radviliškis Music School director, piano teacher methodologist;
- Curator of the competition Diana Sabulienė, head of the piano department of Radviliškis Music School, piano teacher- methodologist.
- Competition coordinator Dovilė Pranaitytė, teacher of Radviliškis Music School.

### **V.CONDITIONS OF THE TENDER**

- Young pianists from music and art schools can participate in the competition.
- Students are divided into four age categories:
  - Category **A** Pupils studying in classes of music school 1-2.
  - Category **B** Pupils studying in 3-4 music school classes.
  - Category **C** Pupils in 5-6 music school classes.
  - Category **D** 7-8 and students studying in the classes of a music school of purposeful education.
- Contestants perform one piece of polyphonic genre.
- The work is performed by heart. Repetitions in the work are optional.

- The contestant's performance is filmed with a camera (possibly a telephone camera) in a stable position. The video must show the full artist. The video is filmed from start to finish without stopping and editing and must be created no earlier than 2020.

- The performance video is uploaded to the participant's personal [www.youtube.com](http://www.youtube.com) account. The link must be set to PUBLIC (function - public).

- Indicate information next to the recording in the following order: NAME, SURNAME, CLASS of the performer; NAME, SURNAME of the composer (in the original language); NAME OF THE WORK (translated into Lithuanian), TEACHER 'S NAME, SURNAME.

A link to the saved record is loaded into the specified section of the participant's application.

- The review and evaluation of the participants' performances will take place in **2021. May 3-14.**

- The list of competition winners will be published in **2021. May 17** On the website of Radviliškis Music School [www.radviliskiomuzika.lt](http://www.radviliskiomuzika.lt)
